Description of the SEP

TPC Group LLC (TPC) entered into a Consent Agreement and Final Order (Order) with the USEPA to establish a real-time air quality monitoring network at the facility in Port Neches, Texas as part of a Supplemental Environmental Project (SEP).

The project is a two-pronged approach to monitor and notify TPC of potential off-site impacts, have the company respond and document actions taken to reduce the potential impacts. When any investigation indicates the potential source of the >25 ppb-v concentrations may be located on the PNO site, TPC posts the information on a specified public website by the 15th of the following month. The posting includes information on the location of the source and the corrective actions taken or reason for inaction.

Monitoring

The air monitoring program is structured to comply with the provisions of the Order by providing and recording information on the levels of 1,3-butadiene at four locations around the facility fence line. Alerts have been established to notify TPC potential off-site impacts of releases from the facility, specifically when the concentration level exceeds 25 ppb-v. Each of the monitoring stations is equipped with a gas chromatograph to measure concentrations of 1,3-butadiene. Two of the stations (#2 and #6) are equipped to monitor and record wind direction, wind speed, wind gust, ambient temperature, and barometric pressure. They also log vector and scalar hourly averages of the wind parameters, and calculate the standard deviation of the wind direction (sigma theta).

The monitoring equipment is operated in temperature controlled shelters located near the four corners of the site as specified in the Order. Please refer to Figure 1, a map of the site showing the locations of the monitoring equipment.

Response

Alerts were established to notify TPC personnel when a monitor detects two readings of twenty-five ppb or more within sixty minutes (1 hour). TPC implemented Fence Line Monitoring Response Procedure to establish the expectations for response to the alerts and document the findings and other relevant information as provided in Appendix F of the CAFO. Figure 2 is a flowchart that provides an overview of the procedure.

Upon receiving the alert, the Control Room Operator gathers meteorological, pollutant concentration and location data from the alarming fence line site. This data is used to help identify the potential upwind areas to be investigated to locate the potential source of the emissions. This information is also passed on to the Shift Supervisor and Outside Operators. The Outside Operators begin field surveys and inspections using audio, visual and olfactory observations and may use portable instruments/monitors to track down the location of the emissions.

The Shift Supervisor also notifies the environmental department of the event. As needed, the Shift Supervisor assigns additional personnel to assist in the identification of the emissions source. Operations personnel document their findings per the procedure.

Once the emissions source is identified, Operations personnel initiate measures to mitigate the emissions release as soon as practical. These measures include isolating the emissions source to end the release and/or contacting maintenance to make necessary repairs. Once the release has been stopped, the Shift Supervisor and Environmental Engineer work together to finalize the reports for completeness to close out the event. If the source of the emissions is not located the escalation process is initiated and followed until the source is identified and/or emissions have ended.

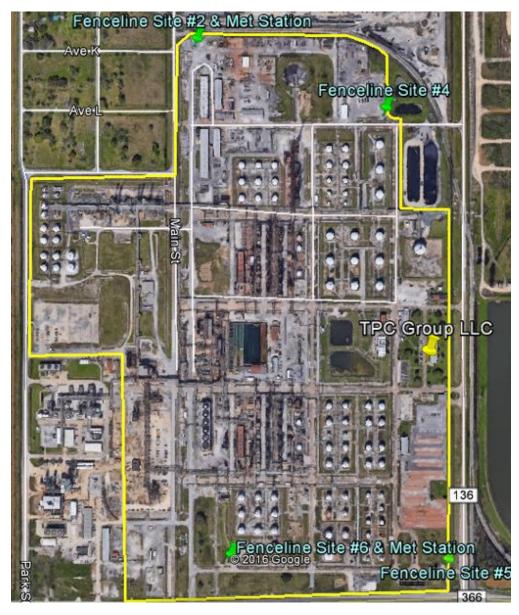

Fenceline Monitoring Response Procedure Flowchart

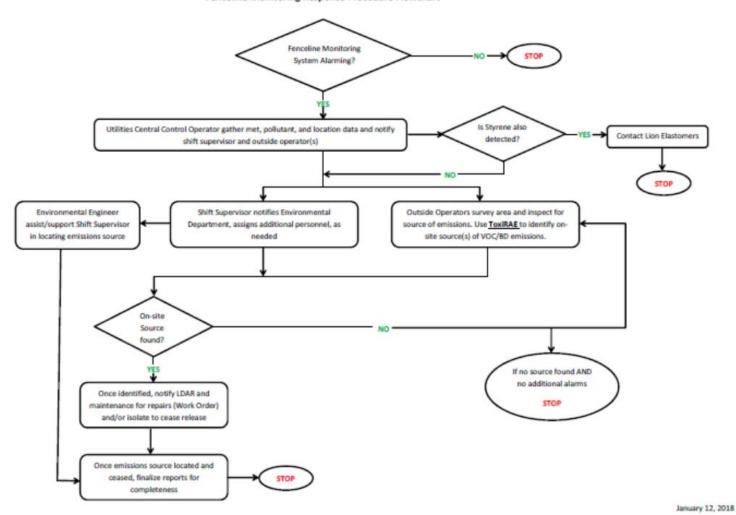

Instrumentation

The primary instrument used by operations to investigate the alert was the ToxiRae meters, which are capable of detecting 1,3, Butadiene in parts per billion (ppb) concentrations. The meters were calibrated every thirty days consistent with the manufacture's recommendation by 24 HR Safety. The meters provided reminders to have the meter calibrated.

Handheld PID meters were calibrated as by the TPC Instrument Technicians per manufacture's recommendations, as the meters, upon startup, indicate when the next calibration is due. Plant personnel also conducted bump tests as signaled as part of the meter's routine operation.

The concentration of Butadiene was measured at the source, when possible by the Fugitive Monitoring (LDAR) technicians utilizing their calibrated equipment, which are operated in compliance with the applicable EPA methodologies for monitoring fugitive components.

Infrared Gas Imaging Camera was onsite and available for use to assist in locating the potential source of the emissions. If it was utilized during the search, its use was indicated on the Posting Form and information regarding its use

Reduction Measures

Upon discovery of a potential source of the emissions located on the PNO site, operating personnel takes action to address the potential source. There are three types of emission sources:

- LDAR- the source was a fugitive emissions component. The LDAR technicians monitors it, if possible, to quantify the leak. It is added to the database as a leaking component. The first attempt must be made by plant personnel within 5 days and the final repair completed within 15 days. LDAR emissions, when managed through the LDAR Program are considered compliant unless they are determined to be an emissions event. Large leaks constituting an emissions event, would have been corrected as quickly as possible as plant personnel responded to the event. Such events are considered to be permit/regulatory violations. See unauthorized emissions below.
- Permitted activities such as MSS activities. Routine MSS activities are routinely performed to maintain
 proper operation. Potential emissions are minimized during these activities by Operations personnel
 following the procedures, which are written to be protective of human health and the environment.
 Additionally, site personnel may take additional actions to minimize emissions. For example: plant
 personnel may spray equipment with water spray to minimize emissions.
- Unauthorized emissions- if the discovered condition does not represent an authorized source or activity, it is addressed as an emissions event, with site personnel taking corrective actions to mitigate the event. These events are reported as required and entered as an event in the TPC Database for tracking non-conformances. Events that generate unauthorized emissions are considered non-compliant. These records are reviewed and incorporated into the company and site Key Performance Indicators (KPIs).

Benefits

The implementation of the program resulted in a higher awareness of the potential for off-site impacts. Alerts provided notification to operations personnel, to ensure they were aware of the readings. Fence line alerts and corrective actions were a standing agenda item in the daily morning meeting. Plant management reviewed the alerts, findings and corrective actions taken as well as the status of fugitive (LDAR) leaks to ensure priorities were placed on repairing any fugitive leaks that were identified as potential sources of alerts. By responding to the alerts by conducting investigations, operations personnel have discovered and mitigated many leaks that otherwise could have had longer durations. This corresponds to a reduction in emissions compared to those that would have occurred without the fence line alert notifications. One event on, September 27, was a reportable event that was isolated and stopped quickly upon discovery. The duration of the event would have likely been longer if operations personnel had not received the alert.

Posting

When the investigation identifies a potential source located on the PNO site, a Fence Line Posting Form is completed. The information about the potential source, the duration of the event, the concentrations

measured by the fence line system during the event, meteorological data, a description of the investigation and corrective actions taken. The completed forms for each month were posted on the designated website by the 15th of the following month.

Air Quality Monitoring Network

Dear Kevin:

This proposal is for the upgrade of the fence line air quality monitoring network for TPC Group at the Port Neches, Texas facility (PNO). The scope of work has two components, the GC equipment upgrade and the ModBus data delivery system upgrade. In addition to these two components a QA Plan in EPA G-5 format will be created for the upgraded network. The QA Plan will describe the layout of the network, the equipment and methods used to collect data, and the quality control protocol. Each component of the scope of work is discussed in detail below.

Fence line GC Monitoring Equipment Upgrade

The scope of work includes purchasing, configuring, and installing four new SRI GC systems at the sites known as Sites 2, 4, 5, and 6 within PNO property boundaries. The SRI systems will measure the target compounds 1,3-butadiene and styrene, with a 15-minute analysis time cycle. We propose to employ GCs with a Flame Ionization Detector (FID) and a Photoionization Detector (PID). The current system uses a dual FID only, and the benefit of having a PID is in the enhanced ability to verify the presence of the target compound vs. another compound with similar chromatographic characteristics, should a co-elution of a target and non-target compound occur. The cost for the recommended system configuration is slightly less than the original system, and the leased GC currently working at Site 6 is an FID/PID configuration.

Each calibration gas delivery system will be refurbished, minimally consisting of having each mass flow controller rebuilt and calibrated by the manufacturer and testing and replacing any solenoid valves that are not functional or leak-free. New sample conditioning drier units will be purchased as will calibration system pumps.

Sites 2 and 6 also have existing meteorological monitoring equipment for wind speed, wind direction, and ambient temperature. These two sites will have barometric pressure sensors added, and Sites 4 and 5 will have ambient temperature and barometric pressure sensors added. This will enable the pollutant data at each site to be corrected to EPA Standard Conditions of 25°C and 760 mmHg and reported as such. There are existing Campbell Scientific CR10X data loggers at each site, and we will send these to the manufacturer for full operational checkout and performance certification. Any repairs that are required will also be performed.

ModBus System Upgrade

The existing ModBus software based data delivery system is obsolete and will be replaced. A new software code script will be created and interfaced to a Kepware server program to enable the TPC plant information system to receive continuous data feeds from the monitoring sites. This system will also connect with Site 3 on Lion Elastomers property, in the same manner as is currently in place to receive data from that site. We have recently replaced two computers in the TPC network and will need to replace the remaining two in order to bring the network to equal footing in terms of computing power to maintain the new ModBus system. Additional software coding work will be conducted to upgrade several data collection features, such as 30-minute rolling averages, wind speed reported in meters per second and interior temperature recorded for each monitoring station.

Costs and Schedule

We propose a Time and Materials budget limit of \$168,000; this budget will not be exceeded without consultation with TPC Group in advance and any additional scope of work items will be identified and acted upon only with approval of TPC Group. Of this total the estimated budget for new hardware and software is approximately \$133,000 with the remainder consisting of the labor for procurement, integration, installation/testing, and software coding tasks.

The Time and Materials arrangement that is currently in place can be extended, including the labor rate schedule that is presented as an Attachment to this proposal. It is the same as the schedule used for the operations budget for the network. All other direct costs (non-labor in nature) will be invoiced as incurred with a 10% markup. These costs include, but may not be limited to, equipment and materials purchases, mileage reimbursement costs, supplies, consumables, and any other reasonably incurred costs involved in upgrading the network. Recertified or replacement calibration and support gases are not included in this quote because they are already part of the annual operations budget for the network.

Our anticipated schedule is to complete the network upgrade within 75 days of receipt of a purchase order. The GC manufacturer currently has an order lead time of 40-45 days, and we will need approximately two weeks to complete the GC configuration and testing before deploying the units to the field. All other tasks can be completed well within this schedule.

Terms and Conditions

We assume that this work will continue according to mutually agreeable Terms and Conditions, which historically has been the TPC standard T&C document. The invoice terms are monthly T&M billing (actual costs incurred). Acceptance of this proposal is conditional on the mutual agreement to continue these terms for this scope of work. The services may be contracted via a Purchase Order referencing the proposed scope of work in this letter. Please be advised that AECOM purchased URS Corporation in 2015 and it is our preference that all new work is conducted under the AECOM name at our Austin, Texas address.

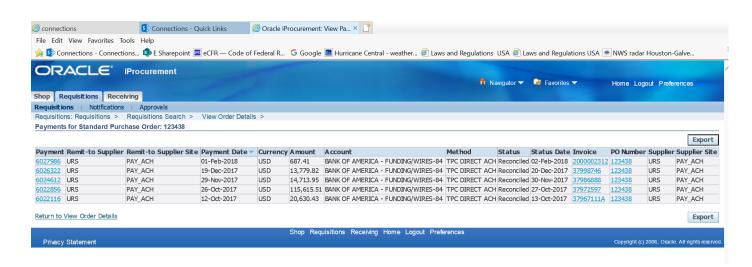

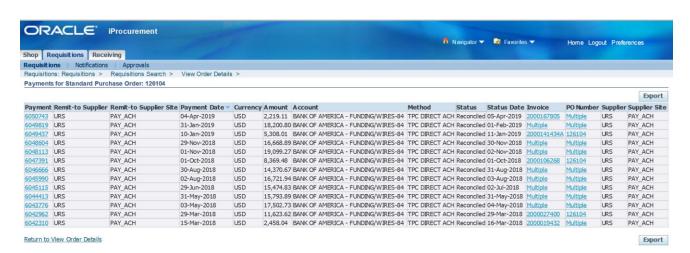

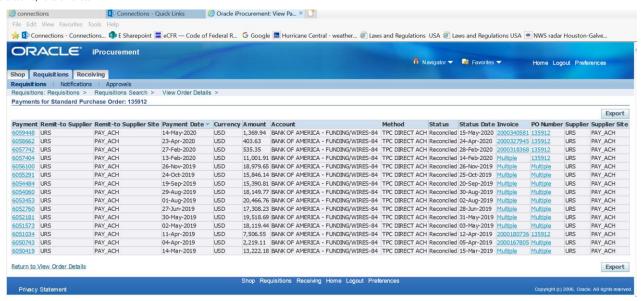
